Financial Assistance Policy Plain Language Summary

Overview

If you do not have insurance or your health insurance did not cover your entire bill, you may qualify for a discount. An application along with your supporting documents may be required. Discounts are for medically necessary care only. If you do not have insurance, you must first apply for coverage through the State or other programs you may be eligible for.

If you qualify for assistance, you may be responsible for a percentage of the total charges based on where your income is on the Federal Poverty Guidelines. We update the Federal Poverty Guidelines yearly.

To Get Help

If you do not have insurance, you may be able to get free or reduced fee care. If you have insurance, you may be able to get free or reduced fee care, after insurance has processed and paid its share.
